#### **Item 4: Print matters**

#### Content

Elena reiterated the importance of editors actually reading the content in the paper when they approve it. Technically, they are saying they have when they approve it.

#### John Passant

Discussion took place around John Passant. Centred around the legalities to do with freedom of speech, right of reply, his behavior. Clarified that Passant has not lodged an FOI request, he has said he will submit a writ of mandamus. Unlikely that his posturing will escalate into any real legal action.

Item 5: Digital media matters

**Videos** 

Ross mentioned there are two videos coming out in the next few days.

Social media use (Woroni accounts)

Discussion around using the Woroni social media accounts, particularly when it comes to potentially controversial content. This mainly concerns a disagreement between Ross and Fergus on a particular tweet.

Ross: We should be erring on the side of caution, not wanting to risk being seen as aggressive etc. When the Woroni account is used, that is the organisation speaking, not an individual.

Fergus: We should be pushing boundaries and being playful on social media, living up to the name of student media.

Cannot leave this issue up to editors' discretion as its very subjective as to what is offensive/aggressive etc.

Motion: New process for social media posts:

- 1. Any post we think could push the limits, we check with Ross first
- 2. Ross decides whether he thinks it should be published
- 3. If there is disagreement (editor who wants to post still wants to do so), they can then go to the board

Moved: Fergus Seconded: Ross No objections

Social media use (personal accounts)

Discussion about how we conduct ourselves on social media as representatives of the organisation.

Conclusion is that it needs to be left up to individual editors' discretion what they do with their personal accounts. They should always be aware though that people associate our names with the organisation.

#### Item 6: Financial matters

Radio expenditure

Tara expressed concern over expenditure accrued in the radio portfolio, specifically the lack of approval and the way the money was spent.

Discussion centred around two amounts for 2 training sessions, one already passed and one to come.

A 24-hour grace period was agreed with 2XX for the training to be cancelled.

Motion: Retrospective approval of previous training session's \$300 + conditional approval of further \$300 training if at least 7 (out of 10) people attend it.
